Article 1 Personal data we process

Article 2 Special and/or sensitive personal data we process

Article 3 Purpose and legal basis for processing personal data

Article 4 Automated decision-making

Article 5 How long we keep personal data

Article 6 Sharing personal data with third parties

AMOY GROUP only provides data to third parties if necessary for the execution of our agreement with you or to comply with a legal obligation.

Article 7 Cookies or similar techniques we use

AMOY GROUP does not use cookies or similar techniques.

Article 8 Access, modification, or deletion of data

You have the right to access, correct, or delete your personal data. Additionally, you have the right to withdraw your consent to the data processing or object to the processing of your personal data by AMOY GROUP, and you have the right to data portability. This means you can request us to send the personal data we have about you in a computer file to you or another organization specified by you.

You can send a request for access, correction, deletion, data transfer of your personal data, or a request to withdraw your consent or object to the processing of your personal data to info@amoygroup.com. To ensure that the request for access was made by you, please include a copy of your ID with your request.

We will respond as soon as possible, but within four weeks. AMOY GROUP also wants to inform you of your right to file a complaint with the national supervisory authority, the Dutch Data Protection Authority (Autoriteit Persoonsgegevens).
